TOURIST VISA INFORMATION

Thank you for your inquiry. We hope the following will be of use to you. We need the following documents:

1. National Passport (must be valid for 6 month)
2. One Arrival Report Form
3. Two Application Forms for tourist visa
4. Three passport photos, must be attached to the forms
5. Tourist visa fee is 25 Euro. **Visa fee is preferred to be paid by Bank Transfer,** but you can also pay by cheque.
6. Self-addressed return envelope with stamps or postage for registered letter.
International coupons for postage fee and Austrian Euro stamps are not accepted.

Visa is valid for a period of 3 months as of date of issue. The visa permits the entry into Myanmar for a maximum stay of 4 weeks (28 days) and is not extendable. Any person 7 years of age or older needs a visa. If children under the age of 7 years have an own passport, they need their own visa. Normally, processing of visa takes 3 days after receipt of application. Visa is issued on National Passport only and **application forms must be filled out completely in English** mentioning the occupation of the applicant (if retired please mention the occupation you retired from). If you are a member of a package tour groups, **a package tour confirmation letter issued by Myanmar registered tour company concerned** must be attached to the visa application forms for the issuance of package tour visas. If needed, please make photocopies of the application forms for other persons. Thank you.

Wir benötigen folgende Unterlagen:

1. Nationaler Reisepass (6 Monate Gültigkeit)
2. Ein Ankunfts Formular (Arrival Report Form)
3. Zwei Tourist Visa Antragsformulare (Tourist Visa Application Form)
4. Drei Passfotos, bitte festkleben
5. Visumgebühr 25 Euro
Visagebühren wenn möglich durch Banküberweisung einzahlen, es kann ebenfalls durch Check bezahlt werden.
Frankierter Rückumschlag (nur Briefmarken) für Einschreibesendung muß beigefügt werden.
Internationale Antwortscheine und Österreichische Euro Briefmarken werden bei Einschreibesendungen von der Deutschen Post nicht akzeptiert.

Visa haben eine Gültigkeitsdauer von 3 Monaten ab Ausstellungsdatum. Die Aufenthaltsdauer in Myanmar ist auf 4 Wochen (28 Tage) begrenzt und kann nicht verlängert werden. Alle Personen ab dem 7. Lebensjahr benötigen ein Visum. Kinder unter 7 Jahre mit eigenem Pass, benötigen ein eigenes Visum. Die Bearbeitungszeit für die Ausstellung eines Visums beträgt 3 Tage nach Erhalt des Antrages. Visa werden nur in den nationalen Reisepass ausgestellt. **Wir bitten, alle Formulare vollständig in Englisch auszufüllen.** Beruf des Antragstellers nicht vergessen. Rentner erwähnen bitte ihren erlernten Beruf. Bei Benötigung mehrerer Formulare für weitere Personen, bitte fotokopieren. Vielen Dank. Wenn Sie eine Gruppenreise gebucht haben, fügen Sie bitte Ihren Antragsformularen eine **Bestätigung des Myanmar Reiseveranstalters** bei, damit ein Touristenvisum mit dem Vermerk "Gruppenreise" ausgestellt werden kann.
