VISA APPLICATION FORM

All Applicants are requested to complete an Application Form and provide one passport sized photograph and a Passport valid for not less than six month.

Visitor Visa - A letter of invitation should accompany requests for visitor's Visa, which must include details of accommodation in Sierra Leone.

Business Visa - Request should be made with a letter of invitation from the business contact in Sierra Leone and must include details of accommodation in Sierra Leone.

The stamped Bank Pay-In Slip should be presented at the High Commission on collection of processed Visas.

A registered S.A.E must be supplied for visas applied for by post to enable the Consular Officer to return the Passport. **The High Commission will not be responsible for any loss of Passport by post.**

Please be informed that it takes three working days to process all Visa Application and fees for rejected Visa Applications are non-refundable.

The Consular Office operates Mondays- Thursdays between: 10am-1.00pm for submissions and 2.30pm- 3.30pm for collections.
